She works with National Peace Action, and many anti-war organizations, and writes and speaks widely across the U.S. and around the world as part of the global peace movement. She has served as an informal adviser to several top UN officials on Middle East and UN democratization issues.

Phyllis has written and/or edited eleven books. Among them are her new *Understanding ISIS & the New Global War on Terror: A Primer*, *Before & After: US Foreign Policy and the War on Terror* and *Challenging Empire: How People, Governments and the UN Defy U.S. Power*.
